



Terms and Conditions

Booking and Cancellations

- ◆ Your booking will be finalised once we have confirmed your date and your non-refundable deposit/payment is received
- ◆ Cancellations of less than 72 hours will forfeit session cost. If advised earlier an alternate date/session will be offered
- ◆ Outdoor Painting Picnics are subject to weather conditions. Will not be able to be carried out in wet weather or extreme conditions. However an alternative date will be offered (subject to availability) or preferably to be set up at Clients request Indoors at an appropriate location offered by Client.
- ◆ 24 hours' notice where possible will be given if location needs to be changed or alternate date required.
- ◆ Client must give at least 4 weeks' notice if date is to be changed.
- ◆ Deposit is non-refundable. By paying the deposit you are agreeing to Terms & Conditions
- ◆ By paying your deposit/payment you agree to these terms and conditions
- ◆ Cancellations of less than 2 weeks prior to your booking will forfeit the total booking cost.
- ◆ Bubbles & Brushes CC is in no way responsible for intemperate weather that may cause the client to cancel their booking and if cancelled you will forfeit the total booking cost. However we will do our best to accommodate any reasonable request to setup in an alternate location providing this does not interfere with other bookings/clients. If there is a chance of inclement weather that will affect the setup, a decision must be made no later than 48hrs prior to the arranged install time where possible.
